DQT is primarily an international remittance platform with integrated Gaming and Beauty services, creating value through low-cost cross-border payments and sustainable tokenomics.

- Licensed Operation: Cambodian Digital Asset Association license (ED342EDTR-12) for legal crypto-fiat transfers
- Tokenomics: 10B total supply, 1B initial sale, fixed price 1 USDT = 1 DQT for stability and trust
- Launch Schedule: DEX launch Nov 30, 2025; Remittance system launch Dec 20, 2025



### **Solution Overview**

The DQT Integrated Ecosystem's primary focus is revolutionizing international remittance with ultra-low fees across 8 major currencies, powered by our Cambodian financial license (ED342EDTR-12).

As an auxiliary coin within the cryptocurrency ecosystem, DQT facilitates seamless cross-border transfers, automatically converting between currencies at the day's exchange rate with minimal processing time.

Complementing our core remittance service, DQT integrates Gaming (MGT migration) and Beauty NFTs as secondary value drivers to create a comprehensive Web3 ecosystem.



#### **8-Currency Remittance System**

Supports AUD/USD/GBP/EUR/KRW/CNY/IDR/VND with automated conversion through licensed financial channels in Cambodia



#### **Ultra-Low Fee Structure**

Up to 90% lower fees than traditional remittance services, with DQT operating as an auxiliary processing coin between currencies





## **Beauty Clinic NFT Technical Design**

NFT membership smart contracts enabling real-world utility through beauty clinic services with integrated DQT token mechanisms.

- Subscription Model: 8-year membership with digital proof of ownership; transferable with service rights
- Multi-Currency Support: JPY, USD, BTC, ETH, USDT with 5-10% discount when paying in DQT
- X Staking Incentives: Exclusive high-APR staking pools for NFT holders; 2-5% DQT cashback on services
- Burn Mechanism: 10% of DQT used for services is burned; portion of clinic profits distributed to holders




## **Burn Mechanisms & Supply Projection**

DQT implements multiple burn mechanisms to systematically reduce token supply and enhance long-term value stability.

- Fee-burn: 20% of trading fees (monthly collection)
- Beauty service-burn: 10% of DQT payments at clinics
- Quarterly burn: Portion of operational profits

#### **Burn Projections:**

- Year 1: ≈ 0.5B DQT (1.25% of total supply)
- Year 5: ≈ 4.0B DQT accumulated (10% of supply)
- Year 10: ≈ 10.0B DQT accumulated (25% of supply)






